Using remote diagnostics to increase patient access



The Challenge

Audiology practices nationwide face two issues that affect their ability to deliver high-quality care:

- An audiologist staffing shortage.
- Increasing demand from patients for hearing testing.

Both problems prevent patients from accessing the hearing care they need in a timely manner, leading to delays that lower patient satisfaction and limit a practice's ability to operate at full clinical and financial capacity.

How Remote Diagnostics Work

1. The patient is roomed by the technician (MA, AuD Tech, OtoTech).
2. The technician connects with the remote audiologist.
3. The remote audiologist participates via virtual connection.
4. The technician connects and conducts video otoscopy.
5. The remote audiologist performs tympanometry/reflexes, OAEs, AC, speech and BC, then reviews results.
6. The practice bills for the tests.
